NOTIFICATION

S.R.O..... (I)/2009: - In exercise of the powers conferred by clause (4) and (4A) of section 2 of the Petroleum Products (Surcharge) Ordinance 1961 (XXV of 1961), rule 3, sub-rule (1) of rule 6 and rule 7 of the Petroleum Products (Petroleum Development Levy) Rules 1967 read with the Ministry of Petroleum and Natural Resources S.R.O. No. 566 (I)/2002 dated 26-08-2002 alongwith S.R.O. No. (I)/1991 dated 11-6-1991 and in supersession of the Pakistan State Oil Company Limited S.R.O. No 439(I) 2009 dated 01.06.2009 the **Pakistan State Oil Company Limited** does hereby, in respect of the petroleum products, refined by the refineries in Pakistan and imports, specified in column (1) of the table below determine the prescribed price specified in column (2) of the said table, declare the Maximum Ex-Depot sale price specified in column (3) of that table, including the rate of Surcharge as specified in the Fifth Schedule of the Petroleum Products (Surcharge) Ordinance, 1961 & specified in column (4) and inland freight margin specified in column (5) of the table, notify the dealers commission specified in column (6) and distributors margin specified in column (7) thereof:

Notes:

(1) The Maximum Ex-Depot sale price specified in column (3) of the above table is inclusive of 16% General Sales Tax and is up to 13 specified locations / depots (excluding Gawadar) of **Pakistan State Oil Company Limited** covering primary freight only, except that for special areas of Baluchistan, Azad Jammu Kashmir and Northern Areas where these include the secondary freight as well. Other than the specified areas, **Pakistan State Oil Company Limited** is allowed to charge secondary freight beyond the 13 locations / depots (excluding Gawadar) upto the respective retail outlets.

As per the directives of the Ministry of Petroleum & Natural Resources vide letter # PL-3(457)/2009 dated June 30, 2009, the Government has levied Carbon Surcharge on Petroleum Products as announced in the Finance Act 2009 and PDL have been withdrawn , the dealers commission in case of direct sale price has been merged in Carbon Surcharge .

(2) As per the directives of the Ministry of Petroleum & Natural Resources vide letter # 3(457)/07-pt dated July 12, 2007, the end consumer prices for Retail and direct sales shall be fixed at par.

(3) This Notification shall come into force with effect from **July 01, 2009**.
