**NOTIFICATION**

This notification is being issued under S.R.O No 566 (I)/2002 dated August, 26, 2002 of Ministry of Energy (Petroleum Division) and in supersession of the Pakistan State Oil Company Limited S.R.O. No. 763 dated June 08, 2022, the Pakistan State Oil company Limited does hereby, in respect of the petroleum products, refined by the refineries in Pakistan and imports, specified in column (1) of the table below determine the prescribed price specified in column (2) of the said table, declare the Maximum Ex-Depot sale price specified in column (3) of that table, including the rate of Petroleum Levy as notified vide the Ministry of Energy (Petroleum Division) **Notification No. PL-457/2022-75 Dated May 31, 2022** & specified in column (4) and inland freight margin specified in column (5) of the table, notify the dealer's commission specified in column (6) and distributors margin specified in column (7) thereof.

(1) Prescribed price includes Cost of supply, petroleum levy, Price differential claim, distributor margin and dealer margin

(2) The Maximum Ex-Depot sale price specified in column (3) of the above table is inclusive of General Sales Tax and is up to 23 specified locations / depots (excluding Gawadar) of **Pakistan State Oil Company Limited** covering primary freight only, except that for special areas of Baluchistan, Azad Jammu Kashmir and Northern Areas where these include the secondary freight as well. Other than the specified areas, **Pakistan State Oil Company Limited** is allowed to charge secondary freight beyond the 23 locations / depots (excluding Gawadar).

(3) As per the directives of the Ministry of Energy (Petroleum Division) vide letter # 3(457) / 07 - pt dated July 12, 2007, the end consumer prices for retail and direct sales shall be fixed at par and to equate the prices, the dealers commission in case of direct sale price has been merged in PDL .

(4) This Notification shall come into force with effect from **June 01, 2022**.
